You are being released from secure detention under the conditions of Home Supervision, pending your next court appearance. This release is conditioned upon your compliance with the provisions listed below. You will be taken into custody and returned to Juvenile Hall should you violate any conditions.

1. You will remain at home at all times, except during school hours when you must be in school and attending all classes. All exceptions must be authorized in advance by the Probation Officer and/or the Court.
2. You must abide by all laws and Orders of the Court and the Probation Officer, as well as the reasonable and proper orders and directions of your parent(s) or guardian(s). You must keep all Court appearances, and must appear as directed by the Probation Officer.
3. You understand that while on Home Detention you are not allowed to have any friends visit you at your residence for any reason. Furthermore, while on Home Detention you are required to call the Home Detention Office before you leave your home and immediately after you return from any authorized activity.
4. You are aware that while on Home Detention, you can not consume or possess any alcohol, illegal drugs or cigarettes. In addition, upon request by the Probation Officer you will submit to chemical testing in order to verify your compliance with the Home Detention Program.
5. You will not have in your person, residence or vehicle any guns, knives or other prohibited weapons. You will submit your person property and vehicle to search and seizure with or without probable cause at any time of the day or night by any peace officer.
